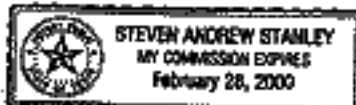

Then when that didn't work I blew into one of the holes in his chest. I looked over at Darlene and she was on the phone calling 911. I ran over to Damon, laying in floor in hallway between wall & side of couch. ~~and~~ The ~~Doctor~~ ~~had~~ ~~no~~ ~~pulse~~ but I could not see any injuries. Police came in and I told them that my boys were STABBED and she told them that they went out the Garage. I ran upstairs to put my pants on. I looked on and ~~the~~ ~~Doctor~~ was crying and I felt relieved he was ok.

I knew that Dean was dead before I ran across street and saw Damon had no pulse but the paramedics revived him and put him in a stretcher and the front door. I ran out yelling that we had to find

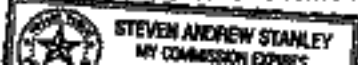

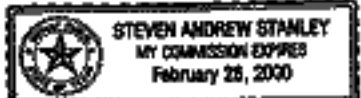
